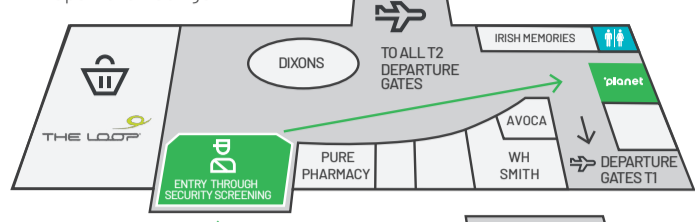


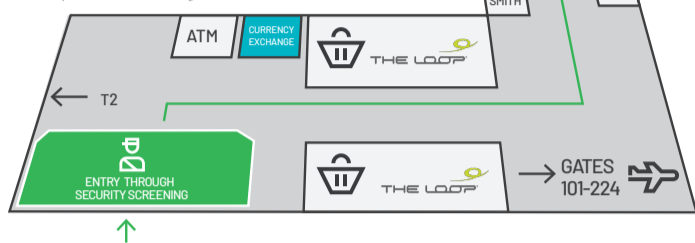

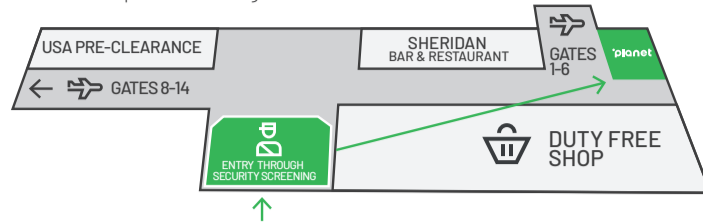
Dublin Airport T2 Departure Lounge

1. Return your completed Tax Free form to the Planet Refund Point in Dublin Airport (Terminal 1 or Terminal 2) or at Shannon Airport. Completed forms can also be returned to the drop off location at Cork Airport, Ireland West & Farranfore Airport.
2. The process at the airport is very simple, average waiting time is only 1 minute.
3. Our staff at the airport will help you complete the process quickly.
4. Individual purchase items with a value over €2000 require a stamp by an EU Customs official. This must be obtained from your final departure point from the EU. In this instance it is advisable to arrive at the airport earlier than usual.

2. 机场的退税流程非常简便, 平均等待时间大约只需1分钟。
3. 我们的工作人员会在机场协助您快速办理退税。
4. 如果单件商品的购物金额超过2000欧元, 则必须由欧盟海关官员盖章验证。您必须在最终离开欧盟的地点取得海关验证。这种情况下, 您最好比平时更提前一些时间到达机场。

Please return your completed forms on departure to our Planet desks at the airport to secure your refund. See airport maps overleaf. Please keep goods you are exporting in your hand luggage when departing.

Important

GB Residents (Excl. Northern Ireland) can shop Tax Free. GB visitors are allowed shop Tax Free within their Import Duty Allowance of £390 or the Euro equivalent. Vat and duties must be paid on imports over this value.

Remember: Irish Nationals resident in GB & other Non-EU countries are eligible to shop Tax Free.



In Ireland, retail price includes sales tax. You must spend a minimum of €75 per transaction to qualify for a refund. Follow these steps to get your refund.



1. Complete your form

Select your refund method, choosing between multiple options including your own Non - EU Credit Card, cash refund or your own Alipay account. Goods must be exported 3 months after month of purchase.

2. Return your Tax Free form

Return your fully completed form with your own Non-EU credit card or Alipay details to receive your refund. In Ireland you can return your forms at the Planet Tax Free desk at the airport.

Get Customs approval

Individual forms with a single item over €2,000 require a stamp by an EU Customs official. Our staff will assist in contacting Customs, however, should you be travelling outside of opening hours you can contact Customs directly by simply picking up the courtesy phone which is located in the Vat refund area, beside the Planet desk.

如果退税单包含价值超过2000欧元的单件商品, 则必须由欧盟海关官员盖章验证。我们的员工可帮助您联系海关, 不过, 如果您在工作时间之外出行, 您可以拨打 Planet 服务台旁边的退税区的免费电话, 直接与海关联系。



Cash refund forms must be returned to Planet Airport Desks within 21 days of receiving your cash refund. Our Airport staff will help you complete the process.
