1.	LOG requested copy of the report daa provided to ACP regarding the viewing platform. MM to provide aircraft observation facility site investigation report to members.	Sent to LOG on 25 July and included in the email to members dated 1 August 2025.
2.	MM suggested daa's acoustic consultants, BAP, can present again to the CLG group in response to members' queries about how noise is modelled for the mitigation measures.	MM contacted BAP and they will present at the next CLG meeting on 18 November 2025.
3.	PS queried the surface water reporting schedule and the Secretariat advised that she will provide copy of the map that was presented at recent a DAEWG and link to results report published on the daa website.	Sent to members on 1 August 2025.
4.	LOG advised that he has not received an explanation for non-compliances with the environmental corridor following complaints to the Noise Team. MM advised she will revert for information.	MM to provide update as part of the matters arising.
5.	PS queried when the Underpass Project will commence. MM advised she would revert.	MM to provide update as part of the matters arising.

- daa welcomed 3.8m million passengers to Dublin Airport in August (up 4.1% on the same period last year).
- Dublin Airport’s 2024 compliance report and the 2024 noise contours have been provided to ANCA.
- The second biannual Instrument Landing System (ILS) testing is due to take place next week on three consecutive nights between 11pm and 6am from Tuesday, 16 September to Thursday, 18 September across the three runways. The checks will be undertaken by a small twin-engine aircraft that will make multiple approaches to each runway at no lower than 100 feet.
- Elevate '25, Dublin Airport’s €2million school support programme, is still open for applications until Friday, 26 September.
- Temporary Noise Monitors: five additional monitors have been delivered and the CLG’s nominated locations for two monitors are now in place:
