daa Actions from Previous Meeting and Updates

Dublin Airport Update

- Dublin Airport welcomed the Irish Government's announcement that non-essential international travel can resume on 19 July as this is the date when Ireland will implement the EU's Digital COVID Certification (DCC).
- In this regard we have an inter-departmental comprehensive operational readiness team working with our airline customers, government agencies and other stakeholders to ensure passengers have a safe and smooth journey through Dublin Airport.
- In advance of the opening of non-essential travel we have published a flip-book guide for people to plan their overseas trips as well as some useful tips and safety information; destinations and airline frequencies are also provided. Dublin Airport Update

- We recently welcomed the announcement by Loganair that it will begin a new service between Dublin and Aberdeen. The airline will operate its four-times-weekly service with a 49-seater Embraer 145 regional aircraft from 5 September, increasing frequency to a daily service from 28 March 2022.
- Just over 1 million passenger flew to and from Dublin Airport between January and June 2021 which is a 93% decline when compared to pre-COVID numbers.
- Construction work to rehabilitate some of the airport's internal roads will commence on 12 July for a period of approximately 15 weeks. This work is weather-dependent and will be undertaken on a phased basis at night between 8pm and 4am. There will be no road closures as access will be reduced to one lane. Traffic management will be in place.



North Runway Update

- North Runway construction works continue with the emphasis now on electrical works, testing and commissioning
- The internal perimeter road has been completed.
- Airfield ground lighting flight checks will take place in July.
- Navaid flight checks will take place in August.
- Land management measures continue with grass cutting, weed spraying and strimming at daa lands.
- Planning application has been lodged for installation of new gates at field opposite Dunbro Lane north, and two fields at Toberburr Junction, all of which will be used as part of our biodiversity programme.
- ORAT (operational readiness and training) activities will take place over the coming months.
