2. Approval of Minutes	Action Owner

3. Matters Arising	
LOG had requested feedback from daa and FCC regarding Prof. Munzel's online presentation of 15 February. MM outlined that Dublin Airport has several noise abatement measures in place, in addition to noise mitigation measures. The Relevant Action planning application included extensive noise modelling, and the planning	



<p>authorities had been provided with detailed data that referenced specific noise contours including WHO's guideline levels. RF asked if daa had any comment regarding the ban of night-time flights as suggested in the presentation, and MM advised that feedback was not point-specific but as already outlined.</p> <p>MG requested daa's feedback be distributed to all members.</p> <p>MMA thanked the Secretariat for circulating the presentation and advised that he did not have feedback on its content. MG asked if FCC had nothing to add given its importance to the local community, and MMA reiterated that he had no further comment.</p>	<p>daa</p>
<p>4. FCC Update – presented by Matthew McAleese</p>	<p>Action Owner</p>
<p>MMA advised that there was one action from the previous meeting in relation to Kilshane Cross road works. MMA outlined the works are on schedule and due to be completed by 8 July 2022.</p> <p>MMA provided an update on the draft Fingal Development Plan advising that it is currently on public display and that FCC has held two drop-in clinics to date in Swords and Blanchardstown, and an online webinar. Two more drop-in clinics are to be held in Balbriggan and Malahide. MMA also noted the last day for submissions is 12 May 2022.</p>	
<p>5. daa Update – presented by Michelle Molloy</p>	<p>Action Owner</p>
<p>MM presented daa's update including the actions from the previous meeting, Dublin Airport's update including Covid restrictions, passenger numbers, Community Fund, North Runway, land management and the underpass planning application.</p> <p>MM advised that there is one outstanding action from the previous meeting, namely IC's request for the high resolution map of NMT locations. MM explained that this file format had been requested and will be issued to members as soon as available.</p> <p>RF had contacted MM prior to the meeting in relation to fly-tipping at daa lands. MM advised that the lands in question were on lease to Irish Water as part of their mains pipeline project and daa's Commercial Property Department had liaised with them regarding a solution. daa understood the importance of this issue and were taking steps to ensure a speedy resolution. MM will continue to engage with RF as further information becomes available.</p> <p>MM advised that daa intends to lodge a planning application in May for an underpass from Pier 3 to the West Apron. MG asked if the next CLG scheduled for 24 May could be brought forward if the planning application is to be submitted before that date. MM suggested that 10 May be provisionally held for the CLG meeting, and a project team member will join the meeting to give members a full briefing. Members agreed this approach and MM will confirm the date as soon as possible.</p>	<p>daa</p> <p>daa</p>

asked if the NMT locations had been finalized because the resident in Dunsoghly had not been contacted yet. MM advised locations had been agreed at the previous meeting and that there would be a permanent monitor at St. Margaret's National School, with the mobile monitor alternating first at Newtown, then Millhead, Dunsoghly and The Ward. Details regarding the precise arrangements would be agreed with individual contacts in each location.
