daa Actions from Previous Meetings

No	Action	daa Response
1.	Contact residents in vicinity of truck holding area on North Parallel Road to advise of upcoming works	Contact was made with the relevant residents on January 9 th 2020 and no issues were raised.
2.	Current cargo truck volumes using Gate Post 9	Total volumes of cargo traffic through Post 9 are typically 45 to 50 vehicles/day, Monday to Friday and a maximum of 15/day at the weekends.
3.	Request Airport Police to be extra vigilant on North Parallel Road for potential attempts at illegal occupation of truck holding area	A request has been issued to Airport Police to include the HGV Holding Area in the daily patrols.
4.	Investigation into ability of noise complaint form to host several complaints on one form	 The system is currently being updated to become more automated in order to speed up complaints processing. Our noise complaints team are liaising with our IT Department on whether it is possible for the number of complaints per form to be increased. However, we remain cognisant that there have been some instances of vexatious complaints in the past and we therefore have to approach this matter carefully to ensure the system remains protected against this recurring in the future. We will update CLG members as soon as we have received a response from the noise complaints team on this matter.
5.	Status update on sound tests on representative samples under the insulation scheme	 Post-works monitoring has been undertaken at most of the Phase 1 representative sample dwellings. Monitoring at the remaining dwellings will take place when works are complete and Handover Packs have issued. Some of the remaining properties were scheduled later in the programme for access reasons.

Dublin Airport Update

- Dublin Airport welcomed a total of 32.9 million passengers in 2019, a 4% increase over 2018.
- About 30.7 million people started and ended their journey at Dublin Airport last year, while almost 2.2 million passengers used the airport as a hub.
- Dublin Airport will welcome 12 new routes including new long-haul services to Shanghai and San Francisco. New short haul destinations include Cairo, Marseille, Rhodes and Tel Aviv.
- We celebrated our 80th birthday on January 19; since that first flight more than 580 million passengers have been welcomed at the airport.
- An updated economic study shows Dublin Airport facilitates 129,700 jobs and generates €9.8 billion in Gross Value Added.
- Fingal is the single largest beneficiary accounting for 89% of the direct jobs impact.
- The Community Fund closes for this round of applications at 5pm on February 12.
- €330,000 was raised for our 2019 charity partners through the fundraising efforts of daa staff, a contribution from the company and by members of the public who also support the scheme through collection points throughout the airport. Each charity received €110k.









North Runway Update

- Dry lean mix concrete has been completed on the runways and taxiways to the west.
- The final layer of pavement quality concrete has been laid on Taxiway Mike, Taxiway N5 and Taxiway N7.
- Dry lean concrete has been completed on the runway to the east.
- Attenuation tank R1 has been installed and backfilled.
- Bulk earthworks largely complete with the exception of those areas yet to be handed over to the contractor (central section, east of site etc.).
