



DA28: Prepare a strategy for 'St. Margarets Special Policy Area' involving consultation between the existing community, Fingal County Council and the Dublin Airport Authority.



Timeframe



Statutory Local Area Plan process

- Finalisation and review of associated studies/assessments and preparation of Draft Local Area Plan (approx. 7 months)
- Up to 35 weeks, from the date on which the draft plan is placed on public display to adoption of Plan
- Initial public display period of 6 weeks
- Open for public submissions for a period of 12 weeks
- (Environmental Reports also open for public consultation)
- Chief Executives Report with associated recommendations set out for consideration by the Elected Members
- Any subsequent material amendments also be placed on public display
