1. Approval of Minutes	Action
Chair requested approval of Meeting Minutes of 28 <sup>th</sup> November 2016; Meeting Minutes proposed by TM and seconded by SC; Approved	
2. Update from Residents	Action
Chair requested that residents outline any updates that they may have for the group and a number of items were discussed:  • GOR confirmed that Dunbro Lane residents had a recent meeting with daa and stated that it was traumatic for them to see fields/hedges being dismantled on lands they had known all their lives	
GOR requested that Fingal County Council review the condition of Dunbro Lane and open the 'cuttings' on the Lane; AMF advised that a review and a programme of works for the area is currently being undertaken; DK requested that Broughan Lane, Kilreesk and Newtown be included in this review	
Special Needs Area: DK requested access to the document that outlines the principal criteria that identifies the Special Needs Area; TM requested that Newtown up to Kilreesk Lane be included in the area; AMF confirmed there will be a consultation process with St. Margaret's on this issue which will inform the geographic area	
daa Extension of Time application: DK queried application process; PR queried whether it made a difference that the request for a 5 year extension was made after the project had commenced; AMF confirmed that an application was received from daa, however as it is a live application, it cannot be discussed. When an assessment of the application is complete, the judgment of the Council will be publicised.	
Roads: RF queried the layout of the new Naul Road and if filter lanes will be used; PM stated that there would be a signalised junction and the road will join St. Margaret's Bypass	
Fencing and security: RF queried the type of fencing that will be used during and after construction and what security this will offer to land owners; PM stated that fencing details would be provided but will be as per the approved road design drawings submitted to Fingal County Council	PM to confirm the type of fencing that will be erected around the site





 Drainage: RF requested a written agreement from daa that lands belonging to RF and BOD and others will not be adversely affected in the future by poor drainage as a result of the construction of North Runway; PM explained the planned drainage process using attenuation tanks and advised that a separate meeting with Dunbro Lane has been proposed to allay concerns around drainage; AMF stated that an Engineer from the Council can also present to the CLG on the topic of drainage AMF to arrange presentation from Council Engineer at next CLG meeting

• Flooding: GOR raised the concern of flooding in the area and highlighted the fact that a local house was flooded two years ago; PM advised that there is a separate group dealing with the affected family on this issue and there was a significant issue with rubbish dumping in drains at the time of this event; AMF advised that the proposed presentation by a Council Engineer will look at the development of the new runway and not the existing runway which is a separate issue; GOR stated that she had been advised by an unknown person from daa that flooding was caused because attenuation tanks couldn't be emptied without causing flooding downstream.

daa to continue engagement with local residents on the issue of drainage

 Fly tipping and rubbish dumping: HG raised concerns regarding rubbish dumping and the programme for cleaning the roads in the area; JN advised that he will raise the question at the next meeting with the Council's Operations Department; TM requested Corrstown Lane to be included also AMF to check if there is a regular programme in place for clearing rubbish and cleaning roads

 Water mains: RF queried the status of the proposed water main from Blanchardstown; PM advised that Irish Water have requested that daa allow space for the main but was unsure of the timeframe for installation as it is within the Irish Water work plans and not daa's – daa are funding the replacement water main along the new road alignment. JN to check if CCTV can be organised in the affected dumping areas

 Animal health and welfare: RF queried what the effects of aircraft noise and emissions will be on animal health and welfare PM to investigate timeframe for installation of water main

 North Runway Second Public Consultation Report: TM queried the status of this report and requested a copy be e-mailed to the group when it is available PM to investigate effects of aircraft noise and emissions on animal welfare

•	Health Checks for local residents: TM requested that daa consider providing health checks to those residents in the noise zones; PM advised that a Health Impact Assessment is currently being carried out as part of the Environmental Impact Statement which will be investigating the issue of health and will also investigate potential mitigation measures for local residents. There are currently no plans to carry out individual health assessments; TM requested that this be considered further.	
•	<b>St. Margaret's School funding for indoor hall:</b> TM queried the status of funding for an indoor sports hall; SOD advised that a Community Fund is currently being set up and an application can be made through this fund – details of the application process will be released later in the year	
•	Access to buy out Scheme for Newtown Cottages: PF requested that Newtown Cottages be considered for daa's buy out scheme due to the excessive noise it experiences and also for a noise monitor to be placed in the area; PM clarified daa's position that those outside of the contours are not eligible and it is difficult to know where to stop if an exception is made for one area	PM to check when a temporary noise monitor can be placed at Newtown Cottages
•	<b>Bus Stop Ashbourne Road</b> : TM queried if a 'hail and stop' system can be reinstated on this road	AMF to investigate if 'hail and stop' bus service could be reinstated on Asbourne Road
•	<b>Road repair</b> : TM queried if repairs could be made to the road off Corrstown Cross which has subsided	JN to investigate if repairs to road can be carried out
•	<b>Noise Experts:</b> TM queried if daa could supply a noise expert for St. Margaret's The Ward AGM in May	SOD to check if noise expert could be provided for St Margaret's The Ward AGM
