Introduction	Action	
Chair advised that Gerard Brennan would represent FCC at the meeting.		
1. Apologies and Absences		
JD advised that LOG and PST had sent apologies.		
2. Approval of Minutes	Action	
Minutes of meeting of 22 July 2025 approved.		
3. Matters Arising	Action	
MM updated on matters arising including BAP's attendance at the next scheduled CLG meeting on 18 November; information provided for surface water reports; underpass update, and non-compliance reporting for aircraft outside of the Noise Preferental Routes (NPR).		
PS commented that further follow-up is required for complaints about flights outside the NPRs. MM advised that she had reverted to the noise team and they assured that non-compliant flights are reported regularly to AirNav Ireland, and while limited information is available, there are a number of reasons why an aircraft might be vectored off the NPR including weather conditions and safety reasons.		
4. daa Update – presented by MM	Action	
 MM provided an update on August passenger numbers, the upcoming biannual instrument landing system testing that will take place next week, the status of the temporary Noise Monitoring Terminals (NMTs) and their proposed future locations following the current rotation. PS noted that a request had been received by SMTW for a temporary NMT in Clongriffin. MM advised that the request had also been received by daa and and because all seven temporary monitors are currently deployed, it would be added to the list for the next rotation in January 2026. 		





5. FCC Update – presented by GB	Action
GB provided an overview of applications for Dublin Airport noting the status of current	
planning submissions including refusal for the demolition of the Terminal 1 spirals and	
the extension granted to daa until 7 January 2026 for response to the request for further	
information in relation to the 32million passenger annual limit.	
6. Residents Update	Action
GOR noted the use of daa land at the rear of Portmellick House for coach parking and	
advised there were signs directing vehicles to this location. MM advised she was not	
aware of this activity but would confer with daa's teams for more information.	daa
