Actions from Previous Meeting and Updates

Dublin Airport Update

- Just over 2.1 million passengers travelled through Dublin Airport in January 2023, a 2% increase on January 2019. In 2022, over 28.1 million passengers travelled through Dublin Airport representing 85% of pre-pandemic passenger numbers in 2019.
- The remaining four temporary noise monitors requested by St Margaret's and The Ward were removed on February 7. The data from all eight locations will now be validated and assessed.
- The indicative illustration for North Runway's revised SIDs will be informed by flight simulations which are ongoing; the illustration will be provided as soon as available.
- daa donated €390,000 to three charities St. Francis Hospice, The Mater Foundation and Feed Our Homeless at a special ceremony at Dublin Airport following staff fundraising efforts and passenger support since 2020. Three new charities have now been nominated for 2023 and they are The Alzheimer Society of Ireland, Ronald McDonald House and Cork Life Centre.
- Over 80 local schools and clubs have shared in almost €400,000 support in 2022 for social inclusion, environmental, educational and recreational initiatives. Dublin Airport Community Fund is due to open on March 20 for the next round of applications.
