

With the resumption of the Charged Permit System at Dublin Airport from April 22, 2022, notice is now being given that new drivers can apply for permits.

Charges for Taxi Permits have been waived for almost two years in consideration of the impact of the COVID-19 pandemic.

Existing Permit Holders will be given priority. The portal will be open for existing Permit Holders from March 10, 2022 – April 17, 2022.

This notice is to grant an opportunity for drivers who do not currently operate at Dublin Airport Taxi Rank to submit notices of interest from March 10, 2022 – April 17, 2022. The permit portal will then open for accepted new drivers from April 18, 2022 and close on May 1, 2022. These new driver permits will be granted on a first come, first served basis after NTA Checks are passed.

From May 2, 2022, in order to operate pickups from the Airport Taxi Rank, you will require one of the new 2022 Permits. The following are the available payment options for the 2022 Permit:

- One-off annual payment: €440.
- For permit years 2022 only: €242 for bi-Annual and €121 for quarterly payments.

Rebate scheme for working peak hours.

To better serve our passengers, daa's aim is to ensure that identified times of short supply are addressed. To encourage supply during these times, we will be offering a rebate as part of a trial incentive scheme.

The cost of a permit breaks down to €8.46 per week. For every week the incentive requirement is met by a Permit Holder, €8.46 will be refunded. Trips eligible for the rebate will begin from the May 2, 2022. Details on exactly how the scheme will operate will be issued at the end of April. The incentive scheme will run as a trial for four months and will then be reviewed and, ideally, extended if working as intended.

Incentive requirement example: *Achieve three points in one week through fare completion to earn the €8.46. rebate. In this example a driver would have to do one pickup on three of the nights in a week between 22.30-02.00.*
